Open Enrollment for Students In-District Transfers

Board-approved policy allows Space Available In-District Transfers and permanent reassignment of in-district transfer student from one school to another.

- Families residing within the AAPS attendance boundaries may apply for a transfer from their assigned school to one of the identified "space available" schools.
- Families receiving these transfers are officially assigned to the requested school instead of their original school.
- Students can stay for all grades offered at that school.
- Transportation will <u>not</u> be provided by AAPS.

Open Enrollment for StudentsSchools of Choice

The Ann Arbor Public Schools Board of Education has approved a non-resident student enrollment policy under Section 105 and 105C of the State School Aid Act (MCL 388.1705) that allows for a limited number of seats for students not living within the Ann Arbor Public School District.

- Students living in a school district within the following ISDs: Washtenaw, Ingham, Jackson, Lenawee, Livingston, Monroe, Oakland and Wayne may apply to enroll.
- Student acceptance is conditional until Ann Arbor Public Schools receives and reviews all school discipline records.
- Once approved and enrolled, the student may remain in the Ann Arbor Public Schools through graduation. This does not prohibit the Ann Arbor Public Schools from expelling a student for disciplinary reasons.
- Number of seats available at each building and/or grade may be limited.


