

**MILLAGE RESOLUTION**  
**PUBLIC SCHOOLS of the CITY OF ANN ARBOR**

On motion of Trustee Lazarus and seconded by Trustee Graynor the following Resolution was presented:

WHEREAS the Board of Education of the Public Schools of the City of Ann Arbor has given due reflection to the budget and operational requirements of the said school district and as to the 2019-20 fiscal year; and

WHEREAS the said Board of Education is desirous of providing for the appropriate certification of hold harmless millage, operational millage, capital projects millage, and debt service millage relative to the said school district;

NOW THEREFORE BE IT HEREBY RESOLVED that as to the 2019-20 fiscal year of the Public Schools of the City of Ann Arbor, and as to that portion of said school district within the City of Ann Arbor, and that portion of the said school district within the territory, townships, or areas outside the City of Ann Arbor, the millage for operational purposes shall be the amount of 3.9687 hold harmless mills and 18.0000 mills for non-homesteads, subject to the appropriate millage reduction fraction.

BE IT FURTHER RESOLVED that, as to the 2019-20 fiscal year of the Public Schools of the City of Ann Arbor and as to that portion of said school district within the City of Ann Arbor, and that portion of the said school district within the territory, townships, or areas outside the City of Ann Arbor, the amount of 2.4500 mills shall be the amount of millage for debt service.

BE IT FURTHER RESOLVED that, as to the 2019-20 fiscal year of the Public Schools of the City of Ann Arbor and as to that portion of said school district within the City of Ann Arbor, and that portion of the said school district within the territory, townships, or areas outside the City of Ann Arbor, the amount of 2.4482 mills shall be the amount of millage for the sinking fund.

BE IT FURTHER RESOLVED that the foregoing amounts are hereby levied by the School District of the Public Schools of the City of Ann Arbor and the Secretary of the Board of Education is hereby authorized and directed to report the same as the school tax levy to the proper assessing officer or officers of the appropriate agencies and the Secretary may provide copies of this resolution when requested by any such appropriate agency.

BE IT FURTHER RESOLVED that the amounts herewith certified to shall pertain to the fiscal year of the Public Schools of the City of Ann Arbor commencing July 1, 2019, except as subsequently altered or amended by appropriate certification.

BE IT FURTHER RESOLVED that a certified copy of the within and foregoing Resolution may be issued with like force and effect as though the original hereof and with the certification hereinafter provided or appended hereto.
